## DIRECTIONS AND MAP TO GAYLORD TEXAN:

### From the Airport:

Take the north exit out of the airport towards highways 635/121. Continue north on 121 and take the Bass Pro exit. Turn left on to Bass Pro. Go straight past Embassy Suites (*on your right*) at the light go left on Hwy 26 West. Continue through the stop light on Fairway Drive. Turn right into the hotel entrance on Gaylord Trail.
